

2019 Cedar Knob G. C. Outing Agreement

_____ outing, guarantees to submit to the following rules and regulations.

1. A **\$250.00** non-refundable deposit must accompany this completed contract. If no check is attached, the requested date cannot be guaranteed. Outing dates/times are on a first come, first serve basis.
2. One person from the outing is to act as the liaison between the group and the golf course management. This person is also responsible for making the outing payment. If your group is having a meal at the restaurant, separate payment checks are required.
3. Any food or beverage served on the premises must be purchased through Cedar Knob.
4. Management reserves the right to deny play to any individual not conforming to Golf Course rules, regulations Or dress code.
5. The dress code policy is proper golf attire. No sweatpants, cutoffs, gym shorts, tee shirts, tube tops, tank tops (both men and women), ripped jeans, boots, heels or football style cleats. The Pro Shop staff has the final decision regarding dress code.
6. **ABSOLUTELY NO COOLERS ALLOWED ON THE GOLF COURSE!**
7. If additional carts must be brought in from an outside source, the supplier of the carts and Cedar Knob will dictate the price for the additional carts. (2019 rate will be **\$36.00**, no additional cost!!!)
8. The liaison must contact the pro shop with the exact number of players at least 10 days before the outing. This is the number of green fees/cart fees/Pro Shop fees that you will be held responsible for. *All fees must be paid one hour prior to teeing off on the day of the outing.*
9. A minimum of \$5.00 per person in prizes (not including 6.35% sales tax) must be purchased at Cedar Knob. There will be no exceptions. All prizes must be purchased prior to teeing off. For outings under 20 players There is a \$100.00 minimum for prizes.
10. No excuses for tardiness will be accepted. Starting times will be forfeited if outing is not present at the Assigned starting times.
11. Outing participants must clear the first tee five minutes after the last assigned tee time.
12. The management must approve any sponsor signs. Sponsor signs shall be placed on the golf course by the Outing liaison, at the discretion of the course management. Scoring is not the responsibility of the Pro Shop. The Pro Shop will, however, provide score sheets, scorecards, callaway scoring rules and closest to the pin/ Long drive materials if needed. If you need help with scoring, please ask well in advance
13. First starting times on Saturday, Sunday, Holidays will be no earlier than 11:00. Starting times during the Week will be as flexible as possible to work around our leagues.

Please note: Any groups wishing to have shotgun start tournaments must comply with the following rules:

1. Weekday shotguns guarantee to pay all fees for a minimum of 100 players.
2. **Weekend/Holiday shotguns guarantee to pay all fees for a minimum of 120 players.**
3. *All fees must be paid 1 week in advance.*
4. *Starting time will be arranged by the Pro Shop*
